## ORDER REQUIRING ERD TO PROVIDE LIBERTY INFORMATION

- ¶1 The Montana Department of Labor, Employment Relations Division retains certain information concerning all workers' compensation claims in the state of Montana.
- ¶2 In order to identify claimants with potential *Flynn/Miller* entitlement;
- ¶3 IT IS HEREBY ORDERED that The Montana Department of Labor, Employment Relations Division, provide to Rex Palmer, Attorney for Petitioners, a printout from its workers' compensation database which shall include the following information:
  - 1. Claimant's name,
  - 2. Name of Insurer,
  - 3. Insurer's Claim number,
  - 4. The Social Security offset amount,
  - 5. The date the offset was first taken,
  - 6. The date of death, if known; and
  - 7. The date of settlement, if the case has been settled

for all claims with a Social Security offset with a date of injury of July 1, 1974, through the present for which the following companies are or were the insurer: **Employers Insurance Company of Wausau**; **Hawkeye Security Insurance Company**; **Liberty Mutual General Insurance Company**; **Liberty Mutual Insurance** 

Corporation; Liberty Northwest Insurance Corporation; Liberty Mutual Property and Casualty Insurance Company; Liberty Insurance Corporation; Liberty Insurance Underwriters, Inc.; Liberty Mutual Fire Insurance Company; Liberty Mutual Insurance Company; National Insurance Association; North Pacific Insurance Company; Oregon Automobile Insurance Company; The First Liberty Insurance Corporation; Wausau Business Insurance Company; Wausau Underwriters Insurance Company; Safeco Insurance Company; American States Insurance Company; American State Preferred Insurance Company; First National Insurance Company of America; General Insurance Company of America; Safeco Insurance Company of Illinois; Safeco Insurance Company of America; and The Ohio Casualty Insurance Company.

¶4 This information is subject to each of the provisions in the May 3, 2005, Confidentiality Agreement filed in this action, docket #131.

¶5 Attorney for Petitioners is responsible for reasonable costs associated with the Employment Relations Division's compliance with this Order.
