COME NOW Robert Ogg, the attorney for Mary Odell; Monte Beck, Stephen Roberts and Lon Dale, common fund attorneys; and Patrick Herron, Claims Supervisor of Brentwood Services, Inc., and by stipulation request a court order approving the payments of common fund attorneys' fees.

### **FACTUAL BACKGROUND**

- 1. Mary Odell was insured through The Montana Hospital Association when she sustained a worker's compensation injury. Mary Odell's claim is subject to the common fund claims established by this Court as referenced in the subsequent paragraph.
- 2. That the attorneys establishing the common fund for impairment benefits pursuant to the Montana Supreme Court decisions in *Rausch, et al. v. State Compensation Ins. Fund*, 2002 MT 203, and *Ruhd v. Liberty Northwest v. Fish, Frost, Rausch, as Intervenors*, 2004 MT 236 are entitled to common funds fees.
- 3. Mary Odell was determined to be permanently and totally disabled. She received an impairment rating in the amount of Four thousand Seven hundred four and No/100 Dollars (\$4,704.00). These funds are being retained by Brentwood Services, Inc., the Third Party Administrator (TPA) for the claim.
- 4. The common fund attorneys request that the TPA for Montana Hospital Association pay the attorneys for Ms. Odell twenty-five percent (25%) of the withheld impairment award in the amount of One thousand One hundred Seventy-six and 00/100 Dollars (\$1,176.00).
- 5. It is contended a twenty-five percent (25%) fee is a fair fee that is in accord with established fee statutes, the holding in the two Montana Supreme Court decisions previously referenced, and past worker's compensation decisions related to payment of common fund attorney fees.
- 6. After the payment of the common fund fees, the Three thousand Five hundred Twenty-eight and No/100 Dollars (\$3,528.00) remaining balance shall be paid to claimant by the TPA.

## WHEREFORE, the parties hereby request:

- 1. that the Worker's Compensation Court order the TPA to pay the amount of One thousand One hundred Seventy-six and No/100 Dollars (1,176.00) to the common fund attorneys;
- 2. that the Court order the TPA to pay three thousand five hundred twenty-eight and no/100 Dollars (\$3,528.00) to Mary Odell;
- 3. that the common fund attorneys' fees in the amount of One thousand One hundred Seventy-six and No/100 Dollars (\$1,176.00) shall be paid to Milodragovich, Dale, Steinbrenner & Nygren, P.C.'s Trust Account for equal distribution to the common fund attorneys; and,

that the Three thousand Five Hundred Twenty-eight and No/100 Dollars (\$3,528.00) balance due to claimant shall be made payable to Mary Odell and sent by the TPA to her attorney, Robert Ogg.
