I have attached the corrected spreadsheet of TTD Claims with Payments Greater Than One Year. Please compare it to your spreadsheet titled the same. It identifies 553 claimants. This list was sent to us from Diana Ferriter along with a December 27, 2004, letter. She had requested that we use this list rather than the one mailed on October 25, 2004. That list only identified 423 claimants. The October 25, 2004, PTD spreadsheet remained unchanged as did the TTD Claims with Payments Greater Than Two Years. Monte intends to ask Diana if she will break down the spreadsheets into another listing for those with greater than 18 months between time of injury and the *Rausch* decision.
