NOTICE TO ACTIVE PLAN I AND II INSURERS

On August 31, 2004, the Montana Supreme Court decision of *Ruhd v. Liberty Northwest Ins. Corp.*, 2002 MT 203, 322 Mont. 478, 97 P.3d 561, 2004 MT 236 (2004), determined that, pursuant to *Rausch*, et al. v. State Compensation Insurance Fund, 2002 MT 203, 311 Mont. 210, 54 P.3d 25 (2002), three law firms were entitled to common fund attorneys' fees for impairment award benefits required by the Rausch decision to be paid to permanently totally disabled workers.

The purpose of this Notice is to advise insurers of their obligation to pay attorney fees pursuant to the referenced decisions. This Notice is also ancillary to the Lien Notice sent by this Court on January 23, 2003, a copy of which is attached.

IT IS HEREBY ORDERED that each insurer or self-insured provide written notification of the following:

- 1) the names and birth dates of all insured permanently totally disabled [PTD] claimants injured after July 1, 1987, their date of injury, and the impairment award including how it was calculated;
- 2) If an impairment award has not been determined for a PTD claimant, it is hereby further ordered that the impairment determination be made as soon as possible, with the three law firms to be advised of the same information itemized in Paragraph 1, and also when the claimant was referred for an impairment determination, and the name of the physician to whom the claimant was referred for an impairment determination:
- 3) the names of all temporary total disability (TTD) claimants who have been on temporary total for more than eighteen (18) months, along with a brief statement of the nature of their injuries and whether PTD classification is likely;
- 4) the names of claimants who have a date of injury subsequent to July 1, 1987 and for whom a settlement was made after the Rausch decision of September 5, 2002 and whose classification was TTD or PTD at the time of the settlement, and whether an impairment was paid as part of the settlement;
- 5) if any claimant injured after July 1, 1987, and before September 5, 2002, is converted to PTD status and an impairment award is determined, the insurer is ordered to notify the firms listed below of any such conversion, including all of the information requested in Paragraph 1; and,
- 6) all names and personal information supplied pursuant to this order shall be confidential and not a matter of public record. The parties and their attorneys shall not release any such confidential information without court authorization.
