COME NOW the above listed insurers ("Responding Insurers"), and respectfully file this motion to extend the briefing deadline for the "gateway" legal issues as set forth in this Court's Order Adopting Order of Special Master dated February 14, 2008. This motion is supported by the following brief. Counsel for Petitioner Schmill has been contacted and advises that she does not oppose this motion.

ARGUMENT

In its Order Adopting Order of Special Master of February 14, 2008, this Court established a briefing schedule for "gateway" legal issues previously identified by Responding Insurers. Specifically, the Order established March 17, 2008, as the deadline for opening briefs; April 21, 2008, for response briefs; and May 12, 2008, for reply briefs. Although Responding Insurers have been diligently attempting to comply with the briefing schedule, it has become apparent that the communication and coordination required by the large number of Responding Insurers will hinder their ability to meet the March 17 deadline.

Effective representation requires contact and coordination with each and every Responding Insurer to insure they are apprised of all relevant issues and provided the opportunity to offer input and direction. Due to the considerable number of Responding Insurers, such contact and coordination is necessarily time consuming and cumbersome. As the "gateway" legal issues to be briefed are essentially Responding Insurers' fundamental defenses to any common fund liability, and thus could result in dismissal of Responding Insurers, such issues are of particular importance to Responding Insurers.

CONCLUSION

The difficulties of coordinating with each Responding Insurer to properly present focused legal arguments and to provide each Responding Insurer with the opportunity to review and approve the arguments on "gateway" issues requires considerable time. As the issues to be presented are unique, and may potentially determine an area of law in Montana that has not been fully developed, it is necessary that each client have adequate opportunity to be involved in the process. An extension of time for the briefing of the "gateway" issues will assure that such opportunity is permitted.

WHEREFORE, Responding Insurers request the Court to vacate the currently briefing schedule, as set forth in the *Order Adopting Order of Special Master*, and issue an order establishing April 14, 2008 as the deadline for opening briefs; May 12, 2008, for response briefs; and June 16 for reply briefs.
