RESPONDING INSURERS' STATEMENT ON IMPLEMENTATION ISSUES

Responding Insurers respectfully submit this Statement on Implementation Issues in response to the Court's May 16, 2008 Order Regarding Appropriateness of Attorney Fee Hearing (Docket # 425.) This Court previously ordered that briefing and decision on practical implementation issues identified by Responding Insurers is deferred until gateway legal issues are resolved. (Order Adopting Order of Special Master, 2/14/08, Docket #410.) The Court's May 16, 2008 Order, however, directs "the parties" to file with the Court a list of the remaining implementation issues in this case which require Court intervention." (Docket #425.) Responding Insurers submit this Statement out of an abundance of caution and to avoid any argument that they have waived any rights or acquiesced with respect to any positions on implementation taken by Liberty or the State Fund. Responding Insurers agree with the Court's prior assessment that it would be premature to address implementation issues with respect to Responding Insurers in advance of any ruling on the gateway legal issues that have now been fully briefed to this Court.

Discussions with counsel for Schmill, which remain premature, may reduce the need for some or many implementation issues to be resolved by the Court. In addition, further consideration of implementation may raise additional or collateral issues that may require this Court's resolution. Responding Insurers nevertheless reiterate the potential implementation issues that they raised on August 31, 2007 as follows:

## PRACTICAL IMPLEMENTATION ISSUES

Assuming that a common fund was to exist as to Responding Insurers (and it should not), numerous implementation issues require resolution by the Court, including the following:

- Notwithstanding any final order on the scope of retroactivity, what Schmill beneficiaries are readily identifiable so as to be included in any common fund?
- Whether deceased claimants may be included within any common fund.
- What are appropriate search parameters and what identification documentation should be required?
- How should potential Schmill beneficiaries be notified?
- Whether potential *Schmill* beneficiaries may opt out of any common fund.
- What procedure should be implemented to locate claimants with changed addresses?
- What mathematical formula allows *Schmill* benefits to be calculated with mathematical certainty across all claim files?
- Whether overpayments on the files may be deducted from the increased benefits paid.
- What calculations should be used where a Social Security offset is present on a file?
- Whether Petitioner's counsel is entitled to a fixed percentage of additional benefits awarded to *Schmill* beneficiaries, or, if under the common fund doctrine, the attorney fee lien asserted by counsel is capped at an amount equal to those fees actually incurred by petitioner Schmill in prosecuting her case.
- How should competing common fund liens be resolved?
