STIPULATION FOR CLOSURE OF SCHMILL COMMON FUND CASE FOR LIBERTY AFFILIATED COMPANIES

COME NOW the above common fund Petitioner and her attorney, the Respondent Liberty NW Ins. Corp. and the workers' compensation insurers identified below, through their attorney, and submit the following STIPULATION FOR CLOSURE OF SCHMILL COMMON FUND CASE for the insurers identified below.

The insurers listed below and the Petitioner filed their STIPULATION FOR IMPLEMENTATION PLAN AND ORDER (Docket Item No. 619) on July 29, 2015, and the Court filed its ORDER ADOPTING SCHMILL IMPLEMENTATION PLAN (Docket Item No. 620) on July 29, 2015. On August 17, 2015 the parties filed with the Court their STIPULATION FOR SCHMILL IMPLEMENTATION PLAN FOR SAFECO AND THE OHIO CASUALTY INSURANCE COMPANY (DOCKET ITEM NO. 626) and the Court in its ORDER ADOPTING SCHMILL IMPLEMENTATION PLAN FOR SAFECO AND THE OHIO CASUALTY INSURANCE COMPANY filed August 18, 2015 (DOCKET ITEM NO. 627)

STIPULATION FOR CLOSURE OF COMMON FUND CASE

The Liberty affiliated companies as of the time of these pleadings subject to the above stipulations and orders include the following workers' compensation insurers;

The parties stipulate that with the exception noted in the paragraph immediately below that the insurers listed above have either complied with the ORDER ADOPTING SCHMILL IMPLEMENTATION PLAN or have filed an affidavit with the Court.

The parties stipulate that the two implementation plans have been completed and that only paragraph 16 of the plans requires further action. That paragraph provides as follows:

16. The Court will issue a closure order ending Liberty's responsibility to search for common fund cases and direct it to make a common fund review of a case, if any, that comes to its attention as a common fund case subject to payment such as one falling within the above inclusive dates and meeting the other criteria in which a payment was made after the date of the Court's closure order.

Other Liberty affiliated companies were previously dismissed by the agreement of the Petitioner and this Court's ORDER OF DISMISSAL, September 14, 2016, (DOCKET ITEM NO.694) and those insurers are not parties to this stipulation.

The parties request the Court to issue the attached closure order for all the parties governed by the two implementation plans and the Court's orders adopting them.
