CLOSURE ORDER FOR SCHMILL IMPLEMENTATION PLAN

The insurers listed above and the Petitioner filed their STIPULATION FOR IMPLEMENTATION PLAN AND ORDER (Docket Item No. 619) on July 29, 2015, and the Court filed its ORDER ADOPTING SCHMILL IMPLEMENTATION PLAN (Docket Item No. 620) on July 29, 2015. On August 17, 2015 the parties filed with the Court their STIPULATION FOR SCHMILL IMPLEMENTATION PLAN FOR SAFECO AND THE OHIO CASUALTY INSURANCE COMPANY (DOCKET ITEM NO. 626) and the Court in its ORDER ADOPTING SCHMILL IMPLEMENTATION PLAN FOR SAFECO AND THE OHIO CASUALTY INSURANCE COMPNY filed August 18, 2015 (DOCKET ITEM NO. 627)

The parties, on 2017, filed their STIPULATION FOR CLOSURE OF SCHMILL COMMON FUND CASE in which they stipulated that the insurers governed by the ORDER ADOPTING SCHMILL PLAN and its ORDER ADOPTING SCHMILL IMPLEMENTATION PLAN FOR SAFECO AND THE OHIO CASUALTY INSURANCE COMPANY have complied with the ORDERS and requested the Court to issue a closure order consistent with ¶ 16 of the two stipulated implementation plans adopted by the above identified orders of this Court.

Having read and considered the STIPULATION and good cause appearing therefor.

IT IS HERBY ORDERED that the parties have complied with the two orders adopting the implementation plans identified above; and
